FROM THE DIRECTOR



On behalf of our dedicated faculty and staff, I am pleased to present to you the 2005–2006 Annual Report of the Fire and Rescue Training Institute at the University of Missouri-Columbia. As you read this year's report, please note the diversity of programming offered by the Institute and the accomplishments of our various program areas.

This past year was our most ambitious training year ever, and it paid off with record enrollment numbers. These high enrollments are due, in part, to the diversity of training and the complexity of the training programs offered this year. Two programs, in particular, that factored in to these record enrollments were the Urban Area Security Initiative (UASI) training in Kansas City and St. Louis and the NIMS training. For the latter training, which all organizations must receive before September 30, 2006, we received requests from several agencies outside the fire service, including Emergency Management, the Department of Health, the Department of Agriculture, and public officials. Our high enrollment numbers are also due to the quality of the training we provide. In my opinion, the quality of our programming is a direct reflection of the dedicated members of MU FRTI who work hard to bring these programs to you and others across Missouri and the nation. Ultimately, it is to them that all the success of these programs should be attributed.

In addition to having seven of our courses endorsed by the National Fire Academy, this year nine courses from our technical rescue and ICS curriculum as well as our Hazardous Materials Incident Response: Technician and Work Practice Refresher courses received approval from Grants and Training (formerly known as the Office of Domestic Preparedness). This makes MU FRTI one of only a few state fire-training programs in the country with approved courses from Grants and Training. This approval allows us to use Homeland Security money to subsidize the cost of these courses and to offer these courses to you at no cost.

In FY05, we started the Exercise and Evaluation Program. This program is designed to assist local and state governments, volunteer organizations, and businesses develop exercise programs and simulations that test emergency plans and procedures. The activities of this new program grew impressively this year, and we expect them to continue to grow more in FY07 as more organizations realize that complying with NIMS includes an evaluation component.

Finally, this year we hosted the 25th Winter Fire School, the flagship program of the Institute. As part of our celebration activities, we brought in former MU FRTI directors, some instructors from the very first Winter Fire School, and the original planning committee. The Winter Fire School has become one of the nation's leading fire schools, in part, because of the vision and contributions of these individuals.

Missouri's fire service continues to be a strong supporter of the Institute. We appreciate your confidence in our ability to deliver quality, professional continuing education programs. While the Institute's most important resource is its people, you—our customers—are our most important priority. We will continue to work hard for your confidence in the coming year.

- Revised the Aircraft Rescue Fire Fighting Techniques for Structural Firefighters course






BUSINESS AND INDUSTRIAL SAFETY



- Developed a CERT Training Management workshop for the State of Missouri














Number of Participants



MUNICIPAL FIRE PROGRAMS/CONFERENCES

While this year was good for fire training contract funds from both the Division of Fire Safety and the Fire Education Commission, it was overshadowed by the amount of funding for NIMS and technical rescue training contracts received from the State Emergency Management Agency and the Urban Area Security Initiative (UASI) sites in Missouri. In addition, we received a grant to purchase rescue equipment, which we will use to support the UASI training in Kansas City and St. Louis. Addressing these two major training initiatives this year was one of the most ambitious training schedules ever attempted by MU FRTI.



This year we also celebrated the 25th Winter Fire School. Over the past twentyfive years, the Winter Fire School has brought in hundreds of state and national speakers to educate Missouri's fire service on timely topics and on issues facing emergency responders. This year alone, we had over 40 courses on topics that ranged from lessons learned from Hurricane Katrina to surviving the routine structure fire. The school continues to receive national and regional recognition for its programming.

We also hosted the Big Rivers Forest Fire Management Compact for the Midwest Wildfire Training Academy, the Summer Fire School, the Train-the-Trainer Weekend, the Instructors Conference, and the Missouri Homeland Security Conference.







In FY06, we had 1,189 courses, 28,408 enrollments, 349,421 instructional hours (at \$6.76 per instructional hour), and 1,165 SFTE. Students from all 114 Missouri counties and from 42 states enrolled in MU FRTI courses. We also delivered training programs in 94 Missouri counties.

GRANTS AND TRAINING (FORMERLY ODP) REVIEW

Grants and Training evaluated nine MU FRTI courses for approval to use Homeland Security funds in the delivery of these courses. This evaluation was an important step toward enabling MU FRTI to assist Kansas City and St. Louis in their Urban Area Security Initiative training. It also is important for the NIMS training, since MU FRTI NIMS: Advanced ICS and NIMS: Command and General Staff programs have been recognized by SEMA as level 300 and 400 equivalent courses for NIMS compliance. The following programs were approved:
