### FROM THE DIRECTOR

On behalf of our dedicated faculty and staff, I am pleased to present to you the Fiscal Year 2006–2007 (FY07) Annual Report of the Fire and Rescue Training Institute at the University of Missouri-Columbia.

During FY07 there were several changes in the staff at MU FRTI. Gary Wilson, who had served as MU FRTI's Director since 2003, resigned at the beginning of the fiscal year. Gary took a leadership role in setting the direction of state and national fire service training initiatives and was a great asset to the Institute during his tenure. As the new Director of MU FRTI, I look forward to continuing to build upon the solid foundation and positive initiatives of my predecessors. The Institute also added a new fiscal manager during the year. Throughout these and other changes, the dedicated staff of MU FRTI has continued the competent operation of the Institute and the delivery of quality fire and emergency service training to Missouri's first responders. We are proud of the training that MU FRTI has been able to deliver, and look forward to continuing to serve you, the Fire and Emergency Services of Missouri, during this next fiscal year.

This past fiscal year was another great year for the Institute, and for state fire service training. MU FRTI provided over 345,000 instructional hours of training. Instruction was delivered through a variety of methods to make courses as accessible as possible. Courses were held in 91 counties, with participants coming from all of the 114 Missouri counties. Also, in FY07 MU FRTI launched

one of the largest rescue training initiatives in its history by developing and conducting a Structural Collapse Rescue Technician program for the St. Louis UASI (Urban Area Security Initiative). Over 240 students were trained in the initial round of courses which will be continuing into FY08.

MU FRTI continues to be recognized for its excellence in programming and the training of Missouri's emergency first responders, as well as the operational assistance it provides in times of emergencies to the state. The Community Emergency Development Program was recognized nationally as an "outstanding program". MU FRTI also provided assistance in six Presidential disaster declarations and one emergency declaration in Missouri during FY07.



SFS is the longest running fire service training event in Missouri, and has a national reputation for skills based training. 



The Aircraft Rescue & Fire Fighting Program continues to provide specialized fire training to the FAA certificated airports in the FAA central region. The Mobile Aircraft Firefighting Trainer (MAFT) was used at new sites this year including: BAA Indianapolis LLC, Indiana; Durango LaPlata County Airport, Colorado; Little Rock Airport Commission, Arkansas; and Nashville International Airport, Tennessee.

The Industrial program is designed to meet the specialized training needs of emergency responders in the industrial setting and includes incipient to advanced firefighting, confined space & high angle rescue, hazardous materials response and mitigation, and incident command training. Courses are conducted "on-sight" at industrial facilities and/or host fire training facilities dependent on the course activities and skills. The institute looks forward to continuing to meet the specialized training needs of Missouri's industrial fire and emergency response personnel.



# **EMERGENCY MANAGEMENT**

The Emergency Management program is a cooperative program of both MU FRTI and Community Development within Cooperative Extension. Due to the completion of the major NIMS training initiative in FY06, the amount of CERT programs declined in comparison this last year. However, the program continues to play a lead role in emergency preparedness and management. The Emergency Management program was recognized by SEMA for its assistance with the disasters caused by the winter storms and flooding this past year. The program also continued to be an active participant in the Extension Disaster and Education Network (EDEN) and received recognition as a national "outstanding program" in community development by the Community Development Society (CDS).

# HAZARDOUS MATERIALS AND COUNTER-TERRORISM PROGRAM

The Hazardous Materials and Counter Terrorism Program continued to train first responders who may be asked to respond to events caused by accident or by terrorist acts that involve hazardous materials or weapons of mass destruction. The program provides Haz Mat courses designed for personnel at the awareness, operations, and technician level. Response training courses can include Chemical, Biological, Radiological, Nuclear and Explosive (CBRNE) events.


The Hazardous Materials equipment trailer received a major renovation during the past year. Shelving and general organization will allow the staff and students to utilize the training equipment more efficiently.

## EXERCISE AND EVALUATION PROGRAM (MU EEP)

Emergency planning exercises are a critical part of a better prepared America. The MU Exercise and Evaluation Program (MU EEP) strives to help communities, businesses, and volunteer organizations assess their capabilities in disaster prevention, preparedness, response, and recovery activities in a risk-free environment. The MU EEP is one of only three programs to be accepted by the Mid-America Regional Council as an approved provider of exercise and evaluation programs.

#### OTHER ACCOMPLISHMENTS DURING FY07

- Provided evaluator support for the Statewide New Madrid exercise hosted by SEMA.
- At the request of SEMA, facilitated the Hotwash for the Southwest Missouri Ice Storm, which was used as the basis for the After Action Report.
- In cooperation with Purdue University, University of West Virginia, and the Centers for Disease and Prevention Control, developed the EDEN Pandemic Influenza Preparedness for Faith-Based Organizations course.

### TECHNICAL RESCUE PROGRAMS/CONFERENCES

In FY07 Technical Rescue Programs launched one of the largest rescue training initiatives in MU FRTI history by developing and conducting a Structural Collapse Rescue Technician course for the St. Louis UASI (Urban Area Security Initiative). The 80-hour course meets the Operations and Technician level standards established by the National Fire Protection Association (NFPA) 1670 and 1006. Over 240 students were trained in the initial round of training which will be continuing into FY08. The course is designed to prepare the emergency responder to respond to, and mitigate incidents involving collapsed buildings and other catastrophic events requiring rescue.

This past year the Institute celebrated the 75th Anniversary of Summer Fire School (SFS) June 5–10, 2007. The program for this year's school included technical "hands-on" training courses in basic skills to advanced fire attack and operations. This year over 20 courses were conducted. Because SFS is the longest running fire service training event in Missouri, a variety of special activities were conducted during the school to celebrate this important anniversary in the history of Missouri's fire service training.


MU FRTI also hosted the Annual Winter Fire School, the Instructors Conference and the Big Rivers Forest Fire Management Compact for the Midwest Wildfire Training Academy.




















# FIELD EXTENSION PROGRAM

The Field Extension Program of the Fire and Rescue Training Institute is responsible for coordinating the operational activities of fire and emergency response training courses, delivered through a field extension format across the state. This program oversees and allocates state funding sources for direct field training deliveries and the scheduling of regional conferences. The state is divided into regions geographically corresponding to Missouri State Highway Patrol regions with an identified Regional Coordinator. These Field Coordinators provide a ready resource to enable fire departments at the local level to access and schedule needed training. Instruction is provided through MU FRTI's adjunct instructional cadre based throughout each region. The majority of the funding to provide courses through the Field Extension Program comes from the Missouri Department of Public Safety - Division of Fire Safety (DFS).

During FY07 four Regional Fire Schools were conducted. These Regional Fire schools provide a variety of openenrollment courses, through a conference venue at host locations across the state. Regional Fire School course offerings are selected with the local sponsor to meet the training needs of the area fire and emergency responders, thus providing them with a broader range of locally accessible training. During FY07 Regional Fire Schools were conducted in: Pulaski County, Cape Girardeau County, Howell County and Newton County.

- The most requested course under DFS HB230 funding is the Vehicle Rescue Technician course, designed to meet the needs of Fire, EMS and Rescue personnel. The class deals with tools and the latest techniques available for extrication.
- The most requested course under the DFS Fire Education Commission funding is *Basic Firefighting Skills*. This course covers the necessary skills for basic firefighting operations with a blend of lecture, practical skills and competency.





# FIRE SERVICE LEADERSHIP ENHANCEMENT PROGRAM

In FY07 the 5th Annual Fire Service Leadership Enhancement Program was conducted. This program is a joint activity conducted by the Harry S. Truman School of Public Affairs, and provides executive leadership training for current and future fire chiefs. This year 26 executive fire officers attended the program.

# DHS/ODP COURSES

Last year nine MU FRTI courses were evaluated and approved by the U.S. Department of Homeland



Security Office of Grants & Training as meeting the scope and goals of Homeland Security. This approval allows Homeland Security funding to be used to support the deliveries of these programs. This approval has continued to initiate training contracts in FY07 with the St. Louis UASI region. It has also initiated training requests from Oklahoma and South Dakota for DHS Grants & Training approved courses conducted by MU FRTI. The following programs are currently approved:

- Introduction to Rope Rescue
- Rope Rescue: Technician
- Confined Space: Technician
- Trench Rescue: Technician
- NIMS: Advanced ICS
- NIMS: Command and General Staff
- Hazardous Materials Incident Response: Technician and Work Practice Refreshers for Decon and Detection.

#### PSTI CONCEPT DESIGN STUDY

Concept Design Study for a Proposed Public Safety Training Institute. The exploratory process for the development of a Public Safety Training Institute (PSTI) that was started last year took another significant step forward in FY07. The plan to contract a Concept for Design Study for a proposed PSTI was approved by MU Extension and the Vice Provost. MU Campus Facilities has initiated the process to select a contract company to work with MU FRTI in developing a conceptual plan and budget for this proposed training facility. The proposed facility will incorporate cognitive education and practical skills training for the technical areas of fire/rescue, emergency management, law enforcement, and emergency medical services. The study project is scheduled to be completed in December of 2007.

#### DISASTER RESPONSE SUPPORT

The Community Emergency Management Program (CEMP) jointly operated between the Community Development Program (CDP) and MU FRTI was responsible for providing information and assistance in six Presidential disaster declarations and one emergency declaration in Missouri during FY07. The program received favorable comments from the state and federal government for the response support.

#### **PROCLAMATION**

Governor's Proclamation of Commendation presented to MU FRTI in recognition of the 75th Anniversary of Summer Fire School (SFS), presented June 7, 2007. The

Proclamation declared SFS as a "unique and esteemed firefighter training event" that has "gained a reputation as one of the finest annual fire service training events in the country."
