<li><input type="checkbox"/> Health certificate</li> <li><input type="checkbox"/> BVD-PI testing is required and may occur at any point in process prior to sale</li> <li><input type="checkbox"/> Evaluate structural soundness, blemishes (scarred eyes, frozen ears, bob-tails, rat-tails, injuries), disposition, etc</li> <li><input type="checkbox"/> Body condition score</li> <li><input type="checkbox"/> Individual sales may require a brucellosis blood test unless from a certified brucellosis-free herd; confer with regional coordinator</li> </ul> <p><b>Pre-sale requirements apply only to heifers consigned for sale.</b></p>

Forms for data collection will be provided from regional coordinators. All data should be forwarded immediately after collection to the Regional Coordinators listed on requirement sheet and to Show-Me-Select Heifer Program, S132B ASRC, Columbia, Missouri 65211.
